# Oncology Pharmacy Residency Sanford Roger Maris Cancer Center

## STRUCTURE

The program is a total of 12-months commitment to residency time. The residency consists of rotations of varying lengths, individually tailored to the needs of the resident. The following rotations are currently available:

### Required Block Experiences

- Orientation (5 weeks)
- Adult Inpatient Oncology (8-9 weeks)
- Adult Bone Marrow Transplant (4-5 weeks)
- Pediatric Oncology (4-5 weeks)
- Investigational Drug Service (2-3 weeks)
- Ambulatory Oncology I & II (16-18 weeks)
- Oral Oncology Therapy (4-5 weeks)

### Elective Block Experiences

- Hemophilia Treatment Center (4 weeks)
- Palliative Care (4 weeks)
- Immune-compromised Infectious Disease (4 weeks)
- Specialty Pharmacy (4 weeks)

### Required Longitudinal Experiences

- Oncology Administration / Medication Safety (11 months)
- Oral Oncology Therapy Management (11 months)
- Oncology Pharmacy Practice (11 months)

## TEACHING OPPORTUNITIES

## QUALIFICATIONS AND APPLICATION

### All residency candidates must meet the following prerequisites:

- Be an eligible graduate of an accredited school of pharmacy
- Hold an active pharmacy license, or be eligible for licensure in North Dakota
- Must be participating in, or have completed an ASHP-accredited PGY1 residency program or one in the ASHP accreditation process

### Application materials must be submitted through PhORCAS by January 3rd and include:

- Letter of interest (including clinical areas of interest and reason for pursuing residency)
- Curriculum vitae
- College transcript
- Three letters of recommendation

Applicants considered for a position will be invited for an interview with pharmacy administration, preceptors and current pharmacy residents in January or February.

The PGY2 positions are determined through the ASHP Resident Matching Program. All PGY2 candidates must register with the ASHP Resident Matching Program.

### Stipend and Benefits

The stipend is competitive and updated annually. Additional compensation is available for optional per diem staffing shifts. Contact the residency program director for the most current information.

Residents are provided with health and dental insurance, life insurance and vacation days (personal, professional, and sick days). Residents are supported to attend the HOPA Annual Meeting and the Midwest Pharmacy Residents Conference.
